TERMS OF AGREEMENT

I understand the term "I" as used in this agreement applies equally to anyone signing this agreement as a relinquishing owner.

I warrant that I am the sole owner(s) of the bird(s) specified in "Parrot Information" and acknowledge that I have the right to transfer ownership to FEBS, and that there are no encumbrances on or other ownership interests to the bird(s). I further certify that I am over eighteen years of age.

I agree that upon arrival at the FEBS sanctuary, FEBS will take temporary ownership my bird(s) while they serve a mandatory quarantine period of at least 30 days and up to 45 days, during which time a full veterinary evaluation (*FEBS Avian Health and Flock Assessment*) will be performed.

I further agree to pre-pay the Parrot Veterinarian Testing fee for each bird for this FEBS standard health testing, including a physical exam, full blood work-up and disease screening for Chlamydia (psittacosis) and Pacheco's Disease (avian herpes virus) and that if my bird(s) history or condition is suspect, testing for Avian Bornavirus or Psittacine Beak & Feather Disease may also be performed.

I authorize my veterinarian of record to release all medical information to FEBS as may be requested. I also warrant that to the best of my knowledge, the bird(s) I surrender to FEBS are not known to have any contagious diseases.

I agree that FEBS will automatically have permanent ownership of each of my bird(s) that pass the *Avian Health and Flock Assessment*. I understand that if one or more of my bird(s) does not pass the Avian Health and Flock Safety Assessment that FEBS cannot take permanent ownership of my bird(s). I agree that in this event, I will work with FEBS to determine the best outcome for my bird(s) and at my discretion, I can have these bird(s) returned to me.

I understand that I am making the pre-paid sponsorship donation specified above in "Sponsorship Donation Information" prior to or the day of my bird(s) arriving at FEBS. With this sponsorship donation, I understand that I am guaranteed that my bird(s) will not be sold, bred or re-homed. I understand that all sponsorship donation fees are non-negotiable and non-refundable.

I understand that I may request an update on my bird(s) 24 hours after initial placement, or as soon as I can if I am traveling, by calling 1-844-352-2473. I further understand that FEBS will provide one update to me during my bird(s) temporary transfer of ownership to notify me of my bird(s) Avian Health and Flock Assessment test results. I agree that after FEBS has permanent ownership of my bird(s) that I may schedule visit(s) with my bird(s) during normal sanctuary operating hours which are posted on the Florida Exotic Bird Sanctuary website (www.flabirdsanctuary.org.)

I agree that FEBS shall not be held responsible for any injuries to my bird(s) during the temporary ownership period or during transport of my bird(s) to or from the FEBS sanctuary. I further agree to defend, indemnify, and hold harmless FEBS from and against all actions, claims, damages, losses,
